2021 - 2022

We are excited as we look forward to the 2021-2022 school year! We also know that we do not yet have all the information needed to finalize what programs may look like with regard to academic models, adult to student ratios, and cohort size. We will use the most up-to-date guidance from the CDC, OCHCA, CDE, and Licensing regarding return-to-school for the 2021-2022 school year.

Primary learning reflects a balance of teacher directed and student directed learning experiences. The California Preschool Learning Foundations and Curriculum Framework provide the basis for all learning in the classroom. Our adult:child ratio does not exceed 1:8.</p> <div style="border: 1px solid black; padding: 5px;"> <p>2020-2021 NOTE: In response to COVID guidelines for school re-opening, we opened the following models in the 20-21 school year:</p> <ul style="list-style-type: none"> • Irvine Virtual Academy (IVA) - A 3 hour distance learning day reflects a combination of synchronous and asynchronous learning opportunities • Traditional Learning - in-person instruction in a non-overlapping AM/PM model with a cohort of no more than 16 adults and students within a 2.5 hour period with a .5 hour daily home activity </div>
<p>Stepping Stones for Learning Tuesday and Thursday 2 hours and 15 minutes Times TBD</p>	<p>Stepping Stones provides a 2 day a week introduction to preschool for our youngest toilet trained learners (30- 42 months) with a focus on the development of social skills, language, learner independence, and the skills necessary for active school participation. The California Preschool Learning Foundations and Curriculum Framework provide the basis for all learning in the classroom. Children will participate in teacher facilitated, developmentally appropriate, whole and small group activities based on children's strengths and interests.</p>
<p>Learning Link Monday, Wednesday, Friday Times TBD</p>	<p>Learning Link is a <u>drop-in</u>, interactive center for parents and their children ages 0-5. Activities will be available for you and your child to do together. Come for a short time or stay the whole time! Our team of professionals will be onsite to answer questions regarding parenting, cognitive/academic, and social/emotional development. Community resources and referrals are available.</p>
<p>Parent Education In person and Virtual</p>	<p>Parent education classes are offered on a variety of child development topics for young children. See handout for classes, dates, and times.</p>

For General Education Preschool:

1. There is a non-refundable registration fee of **\$120.00 for General Education Preschool/ \$30 for Stepping Stones for Learning** due upon submission of a completed enrollment packet. For siblings or returning students the non-refundable registration fee is **\$65.00**.
2. Tuition payments are based on a **daily rate of \$40.00 for General Education Preschool/ \$30.00 for Stepping Stones for Learning** multiplied by the number of school days annually, distributed between 10 equal payments.
3. **No refunds or credits given if a child is absent, ill, on vacation or due to an emergency school closure.**
4. Notification of withdrawal from the program must be **prior to the tuition due date**. Tuition dues are **non-refundable** if notice is given after tuition due date.
5. There will be an additional **\$25.00 late charge if the payment is received after the due date**. All services will be terminated immediately if payment is not received **within seven days of the due date**.
6. Payments can be made by cash, check, money order, credit card, or online via www.MySchoolBucks.com. If paying by credit card or debit card there is a 3.95% service fee. Checks are payable to Irvine Unified School District; write your child's name and room number on the check. If a check has been returned for insufficient funds or a closed account, checks will no longer be accepted and a \$25.00 fee assessed. Thereafter, cash, money orders or certified checks will be required.

<p>Stepping Stones</p> <p>Tuesday and Thursday 2 days a week/2.15 hours a day 30-42 month (2.5-3.5 years)</p>	<p>\$222 monthly</p> <p>Tuition is always due on the 1st of the month, August - May</p>
