## ECLC Preschool Offerings

(Pending 2021-2022 State and Local Guidelines for Safe Re-Opening)

We are excited as we look forward to the 2021-2022 school year! We will continue to use the most up-to-date guidance from the CDC, OCHCA, CDE, and Licensing regarding return-to-school to ensure safety and compliance for students and staff. The information below is based on opening without restrictions.

<p><b>General Education Preschool</b>  Monday - Friday  8:00am-11:00am  11:45am-2:45pm</p> <p>Tuition see reverse side*  \$120 Non-refundable  Registration Fee *  \$65.00 for siblings or returning students</p>	<p>Our preschool classrooms typically serve 21-24 3 and 4 year old toilet trained students. Primary learning reflects a balance of teacher directed and student directed learning experiences. The California Preschool Learning Foundations and Curriculum Framework provide the basis for all classroom learning. The adult:child ratio does not exceed 1:8.</p> <div style="border: 1px solid black; padding: 5px; background-color: #f0f0f0;"> <p><b>2021-2022 NOTE:</b> ECLC will be offering in-person instruction in a non-overlapping AM/PM model for 3 hours daily.</p> </div> <p><b>*No charges for income qualifying families</b> based on the California State Preschool Program regulations.</p>
<p><b>Stepping Stones for Learning</b></p> <p>Tuesday and Thursday  2 hours and 15 minutes  8:30am-10:45am  (30-42 months by Sept. 1)  11:30am-1:45pm  (42-52 months by Sept. 1)</p>	<p>Stepping Stones provides a 2 day a week <b>introduction</b> to preschool for our youngest toilet trained learners (30- 42 months) with a focus on the development of social skills, language, learner independence, and the skills necessary for active school participation. Our PM class provides an opportunity for preschoolers (42-52 months) to participate in a <b>bi-weekly</b> preschool program. The California Preschool Learning Foundations and Curriculum Framework provide the basis for all learning in the classroom. Children will participate in teacher facilitated, developmentally appropriate, whole and small group activities based on children's strengths and interests.</p>
<p><b>Learning Link</b>  Monday, Wednesday, Friday  8:45am-10:45am</p>	<p>Learning Link is a <b>drop-in</b>, interactive center for <b>parents and their children ages 0-5</b>. Activities will be available for you and your child to do together. Come for a short time or stay the whole time! Our team of professionals will be onsite to answer questions regarding parenting, cognitive/academic, and social/emotional development. Community resources and referrals are available.</p>
<p><b>Parent Education</b>  In person and Virtual</p>	<p>Parent education classes are offered on a variety of child development topics for young children. See handout for classes, dates, and times.</p>

For General Education Preschool:

1. There is a non-refundable registration fee of **\$120.00 for General Education Preschool/ \$30 for Stepping Stones for Learning** due upon submission of a completed enrollment packet. For siblings or returning students the non-refundable registration fee is **\$65.00**.
2. Tuition payments are based on a **daily rate of \$40.00 for General Education Preschool/ \$30.00 for Stepping Stones for Learning** multiplied by the number of school days annually, distributed between 10 equal payments.
3. **No refunds or credits given if a child is absent, ill, on vacation or due to an emergency school closure.**
4. Notification of withdrawal from the program must be **prior to the tuition due date**. Tuition dues are **non-refundable** if notice is given after tuition due date.
5. There will be an additional **\$25.00 late charge if the payment is received after the due date**. All services will be terminated immediately if payment is not received **within seven days of the due date**.
6. Payments can be made by cash, check, money order, credit card, or online via [www.MySchoolBucks.com](http://www.MySchoolBucks.com). If paying by credit card or debit card there is a 3.95% service fee. Checks are payable to Irvine Unified School District; write your child's name and room number on the check. If a check has been returned for insufficient funds or a closed account, checks will no longer be accepted and a \$25.00 fee assessed. Thereafter, cash, money orders or certified checks will be required.

<b>Stepping Stones</b>  Tuesday and Thursday 2 days a week/2.15 hours a day  (30-42 months by Sept. 1) 11:30am-1:45pm (42-52 months by Sept. 1)	<b>\$222 monthly</b>  Tuition is always due on the 1 <sup>st</sup> of the month, August - May
